TRACK 1

SESSION: **Current Medicaid Audit and Oversight Environment**

SPEAKER: Mary Thornton, President & Founder, MTA

DESCRIPTION: The Deficit Reduction Act substantially changed the risk profile for health care providers and especially those who rely primarily on Medicaid funding. New auditors, new monies dedicated to Medicaid enforcement and oversight, and new concepts in Medicaid program integrity. This new business environment, which looks to be with us for the foreseeable future, requires organizations to think differently about audit risk management. This workshop will outline this new environment, suggest changes for how risk is managed internally, and push for the implementation of a compliance infrastructure in all behavioral health organizations regardless of size. The role of finance and especially the CFO will be explored and the contribution of this department to the overall compliance of the organization will be emphasized. Mary Thornton has attended a number of our FARO conferences and is a welcomed speaker. She brings a national perspective to the issues of compliance and reimbursement that helps providers see not only what is happening but what is likely to happen in the future as well.

- Potential financial cost, operational impact, and brand damage resulting from a data breach involving sensitive customer data can be significant and often crippling to a company, its brand, or its long-term viability.
- The threat of a data loss and information leakage from insiders is on the rise.
- Companies are storing sensitive information of all types (Personal Identifiable Information [PII], Payment Card Industry [PCI] and healthcare records).
- The growing need to share data among colleagues, third-party vendors, customers, and partners.
- New markets are emerging for stolen data, which help criminals gain competitive advantage.
- The data security regulatory environment is expanding and becoming more complex.

To protect data from these types of risks, organizations must turn to the next generation of data security solutions and revamp the thought process of how data is used and shared.

Also reviewed are examples of how Six Sigma can be applied to the behavioral healthcare setting and recent trends in North Carolina's public behavioral health setting. Six Sigma makes us realize that 90%, or even 95% success in a process is not always good enough and provides a framework for reaching 99%+.
