SESSION: Current Fair Labor Standards Act Compliance Issues – FLSA Investigations & Litigation

SPEAKER: Mark Knuckles, Human Resource Management Consultant Mark Knuckles Associates, Inc.

DESCRIPTION: Attendees will learn the latest enforcement activities of the USDOL, what investigators are looking for and the compliance issues found in investigations and in litigation. Subjects covered will include the Part 541 salaried exemption tests, what positions and duties are being challenged, how investigators are attacking Administrative and Professional exemptions. Attendees will learn how to protect their exemptions and what position descriptions must say and document. The presenter will also discuss the new definition of hours of work, how the "principal activities" can start the work day and what is the "continuous work day rule." Subjects will also include the latest enforcement information on the contractor v employee issue, common mistakes with the fluctuating work week plan, salaries and deductions, on-call and standby pay, volunteers and other "hot button" compliance issues with the FLSA. The presenter, Mark Knuckles of Hickory, North Carolina, is a recognized expert with FLSA compliance. His firm, Mark Knuckles Associates, Inc. provides "expert witness" services and testimony for plaintiffs and respondents across the nation, including litigation against employers in North Carolina. The firm is also assisting public and private employers under investigation by the U.S. Department of Labor Wage Hour Division and the Office of Federal Contract Compliance Programs, OFCCP. Mark Knuckles Associates is an approved training provider by the Human Resource Certification Institute, HRCI, and application is being requested for five (5) hours rectification credit for PHR, SPHR, and GPHR certifications.

DESCRIPTION: Learn what the three main confidentiality laws (state MH/DD/SA law, HIPAA, and 42 CFR Part 2) say about disclosing confidential information when a client reports past criminal behavior, current criminal behavior, or a plan to harm another individual. Session will outline options available to treatment providers who must balance client privacy with public safety.

DESCRIPTION: This session includes Parameter Fields – Common uses, using parameters to affect grouping, sorting, formatting, and detail level of a report, range and multiple parameters; Sub-Reports – Unlinked vs linked sub-reports, parameters in sub-reports, tips for working with sub-reports; Adding Charts – Using the Chart Expert, drilling down on chart elements; Running Total Fields – Using variables to create and display running totals in places other than footers; Variables – Arrays and ranges, variable scope and evaluation time, variable and formula overkill; Formulas – Programming shortcuts explained, Crystal syntax vs Basic syntax, formatting strings; Using SQL within Crystal Reports – Displaying the SQL statement, writing your own SWL statement from scratch, creating a simple DSN for use with SQL Server databases, viewing reports in NetSmart based on an external database; External Databases – Reporting on Medicaid Paid Claims, Value Options and NC-TOPPS data stored in an external SQL Server 2005 database; and Other Topics – Using report templates and graphics for a uniform look, changing and displaying document properties, "Report Options" vs Crystal options and the most common settings for each, limitations of the Crystal viewer in NetSmart.

With this information at hand, the current process can be analyzed in detail before it is overhauled so that true requirements get into the specification and unnecessary data, flow, work...is kept out.

DESCRIPTION: The North Carolina Treatment Outcomes and Program Performance System (NC-TOPPS) is a webbased system that is used to collect information on the life outcomes of individuals, ages 6+, receiving publicly funded mental health and substance abuse services. In the last two years over 1000 providers have participated in this system, providing a pool of data that can be used to inform both evaluation and the quality improvement of the public service system. This session presents some of the ways in which NC-TOPPS data and reports can be used strategically to improve programs and services at the local, regional and state level.

SESSION: Virtualization Deep Dive

Best practice approaches to be included in the waivers include: Person Centered Planning, Self-Direction, the use of the Supports Intensity Scale, the development of a Risk Assessment process, and enhancements to the current waiver service definitions.

Also reviewed are examples of how Six Sigma can be applied to the behavioral healthcare setting and recent trends in North Carolina's public behavioral health setting. Six Sigma makes us realize that 90%, or even 95% success in a process is not always good enough and provides a framework for reaching 99%+.

SESSION: Protecting Data Through Management Technology and Encryption

SPEAKER: Randall Bennett, Secure Enterprise

DESCRIPTION: As your business faces sophisticated security attacks, information security practices have evolved from basic perimeter defenses to a defense-in-depth model, in which multiple countermeasures must be layered throughout your network internal and external infrastructure. Although multiplayer defenses are necessary, they increase the complexity of managing network security and make it more difficult to effectively identify and mitigate threats and meet compliance requirements.
