NC MHDDSA System: Thoughts on the Near Future of the System

DESCRIPTION: Any organization using public funds is accountable for the services it provides and the way those resources are used. Fiscal accountability is demonstrated through strong internal controls, budgetary and legal compliance, accurate and timely financial reporting, sound business practices, and a culture of strong moral and ethical behavior. DESCRIPTION: The North Carolina Treatment Outcomes and Program Performance System (NC-TOPPS) is a web-based system that collects information on the life outcomes of individuals, ages 6+, receiving publicly funded mental health and substance abuse services. This interactive session is designed to facilitate participants' understanding of how NC-TOPPS can be used by multiple stakeholders to improve programs and services in the public treatment system. Attendees will learn about some new on-line tools in addition to being guided through an exercise that uses real data to demonstrate the type of reports available and potential uses of these reports and data. Attendees should leave the session with an understanding of how to frame a question, how to access the appropriate data, how to approach analysis, and how to present this data to different stakeholders. Attendees are *not* expected to have any prior data skills to participate in this session.
